Covid Safety Precautions:

- For 10 days before Camp KEEP I will self-monitor my health. I will truthfully report any COVID-19 symptoms or known exposures on the Pre-Trip Health Screening Form before departing for camp.
- For 10 days before my trip, as much as possible, I will avoid non-necessary travel, crowded places, and other activities where there may be increased exposure risk to COVID-19.
- I am allowed to bring 2-ply fabric or surgical masks to camp. Bandanas or neck gaiters are not recommended. (Please contact your school for assistance if needed).
